

## NHC Family Code of Conduct and Liability Waiver

- I will be encouraging and supportive of my fellow students.
  
- I will obey the Golden Rule of treating others as I want to be treated and show respect for myself, my teachers and fellow students, as well as anyone else around me, including the facility at large.
  
- I will stay in my designated area during class, and when I am outside of my classroom and in common areas, I will talk quietly and not disturb any other church business or functions.
  
- I will respect the property of others, including teachers and fellow students. If I damage any NHC or church property, or teacher's property, I will immediately report it to my teacher. I understand that my parents will be financially responsible for any damage I may cause, accidentally or otherwise.
  
- I will conduct myself in a manner that reflects positively on Christ, on homeschooling, and on my family at all times; this includes the show of respect to and by students and adults.
  
- I will do my best to fulfill the requirements of the course(s) I am taking and the expectations of my teacher(s). I am responsible for my work, papers, and belongings, and will come to class prepared with any materials and assignments that are required.
  
- I will remember that I am a guest in this facility. I will treat this facility as the Lord's house. I will be respectful of church property, NHC property, and teacher's property.
  - No students/siblings are permitted outside on the church lawn or the playground unless accompanied by a parent. This includes teens. This is a liability issue.
  - No red beverages or gum are permitted in the rooms/hallways.
  - Parents/students must stay within the NHC area of the church. Remember that people are working in the offices and may be on the phone or in a meeting, so please try to remain as quiet as possible when in the hallways.
  - No students are allowed in the kitchen unless accompanied by a parent or teacher.

3. If the issue is still not resolved, the student will be asked to not return to classes. This is without any refund from NHC.
